Guidance Notes:

1. Number of residents affected:

Low = 1 to 10. (50 points)

Medium = 11 to 100. (100 points)

High = 101 and over. (150 points)

Cost: Total installation cost and annual energy and maintenance costs.

Low = €2,000 to €5,000 (150 points)

Medium = € €5,000 to €10,000. (100 points)

High = €10,000 and above (50 points)

3. Traffic Types

Type 1 = motorised vehicle only. (50 points)

Type 2 = pedestrian only. (100 points)

Type 3 = pedestrian and motorised vehicle. (150 points)

4. Ambient Light: The level of light that currently affects the location .

Low = no contributory light with no visibility of the proposed location. (75 points)

Medium = some contributory light but still quite dark. (50 points)

High = enough ambient light which allows the proposed location to be visible. (25 points)

5. Age of request:

1 to 10 years from date of initial request to be included on register.

(7.5 points for each year from date of request. Yr 1 = 0 points, Yr 10 = 75 points)

6. Age Demographic of area:

Type 1 = Predominately young adults. (25 points)

Type 2 = Predominately families with young children. (50 points)

Type 3 = Predominately elderly adults. (75 points)

7. Availability of network connection:

Low = No available network connection. (25 points)

Medium = Network connection available within 30 to 100m. (50 points)

High = Network connection available within 30m. (75 points)

8. Visual Impact:

Low =no visual impact on the landscape. (75 points)

Medium = some visual impact on the landscape. (50 points)

High = significant visual impact on the landscape. (25 points)

9. Wildlife:

Low = No wildlife present. (75 points)

Medium = Some wildlife present or potential. (50 points)

High = Established wildlife presence. (25 points)

10. Crime: The level of criminal activity that affects the proposed location.

Low = virtually no crime. (15 points)

Medium = some crime from time to time. (30 points)

High = regular crime. (50 points)

11. Traffic Volume: The level of traffic that affects the proposed location.

Low = 0 to 500 AADT. (15 points)

Medium = 500 to 1500 AADT. (30 points)

High = 1500 AADT and above. (50 points)
