
Site location & context

The site of the proposed development is located c.3km west of Naas Town Centre in the townland of Jigginstown. The site is located adjacent to and south west of the Newhall Retail Park, however, no access to the site is available from this location. The site is a disturbed site with uneven ground levels and is bounded to the north by the local road network/motorway link to southbound lane of the M7, to the south and west by greenfield lands in agricultural use and to the east by a greenfield/vacant site with the internal distributor road serving the Newhall Retail Park, located beyond. There are mature vegetation/field boundaries located to the south and west of the site. Adjacent land uses include a vehicle sales / vehicle storage facility located to the north of the site. Access to the site is via the public, local secondary, road to the north, which is currently being reconfigured as part of the M7 widening scheme. The site has a stated area of 1.88ha.

Response of the Housing Section to the reports received from internal Kildare County Council Departments and Prescribed Bodies

The Roads, Transportation and Public Safety Section has prepared a detailed report on the submissions received (detailed in Appendix # attached) and, where relevant, has given an undertaking that the issues/comments will be addressed by their incorporation into the detailed design stage of the project and the management of the proposed development.

Relevant Development Plan Provisions

Kildare County Development Plan 2017 – 2023

Chapter 7 of the Plan sets out the policies and objectives of the Council in relation to Movement and Transport Policy NR7 specifically seeks to protect the capacity, efficiency and safety of the national road network.

The Roads, Transportation and Public Safety Section has prepared a report outlining how the proposed development is consistent with the proper planning and sustainable development of the area and the Kildare County Development Plan 2017-2023.

The site is somewhat unique in that it was previously located within the Naas Environs Plan of the Kildare County Development Plan 2011-2017 and was zoned NE 1 – Industry and Warehousing. Development of the type proposed, would have been in accordance with the provisions of the zoning objective of the lands as set out in the former County Development Plan.

The site is not included in the Environs Plans of the current Kildare County Development Plan 2017-2023. The land now falls within the development boundary of the Naas Local Area Plan. A Draft Naas Local Area Plan 2019-2023 is currently on public display.

Draft Naas Local Area Plan 2019-2023

The site is located within the development boundary of the Draft Naas Local Area Plan 2019-2023 on lands zoned Objective H – Industry and Warehousing – to provide for industry, manufacturing, distribution and warehousing. The purpose of the zoning is to provide for industrial and warehousing uses. Other uses, ancillary or similar to industry and warehousing will be considered on the merits of the proposed development and may be acceptable in this zone. Where employment is a high generator of traffic, the location of new employment facilities at appropriate scale, density, type and location will be encouraged to reduce the demands for vehicular travel.

The site forms part of a larger portion of H zoned lands located to the south and west, with a specific objective, MTO6.1 to investigate the feasibility of providing an outer eastern relief road connecting Junction 8, Johnstown Interchange with Junction 10, Newhall Interchange, with the aim of providing an alternative route to relieve pressure on the town centre and eastern area of the town.

It is considered that development of the type proposed would be in accordance with the provisions of the zoning objective for the lands indicated in the Draft Naas Local Area Plan. Furthermore, having regard to the location of site adjacent to the national / motorway road network, to the intended use of the site for the Council's Machinery Yard and a Regional Salt Barn to serve the wider region, outside of County Kildare and to the character and context of surrounding development, it is considered that the proposed development would be consistent with the proper planning and sustainable development of the area.

Assessment/Evaluation

The proposed development comprises the following:

- a new Machinery Yard to replace the existing Machinery Yard currently located in Newbridge Town Centre;
- a Regional salt barn for use within and by local authorities in the region during cold weather spells

The proposal includes:

- Removal of inert soil;
- Provision of:
 - o a two storey administrative building which includes:
 - storage areas;
 - welfare facilities:
 - canteen facilities;
 - offices:
 - training room
 - o a four bay mechanical workshop including:
 - shot blasting:
 - spray painting;
 - welding facilities
 - o a Regional salt barn and welfare facilities;
 - o brine manufacture and storage facilities;
 - o fuel storage:
 - o external bitumen and road chipping storage areas;
 - o covered truck wash area;
 - o weighbridges;
 - o car park, truck and van parking;
 - o rainwater harvesting facilities:
 - o landscaping, boundary treatment and
 - all associated site development works.

Principle of development

It is considered that the principle of the development is acceptable, having regard to the zoning of the site in the former Kildare County Development Plan 2011-2017 which identified the subject site as suitable for the development of the type currently proposed, the current Draft Naas Local Area Plan 2019-2023 and having regard to the nature, scale, purpose and location of the proposed development with easy access to the M7 Motorway and local road network.

Siting and Design

Removal of inert soil

The proposal includes the removal of surplus soil during construction, which is proposed to be transported to licensed facilities within the region. It is estimated that c. 20,000-25,000 cubic metres of soil will be removed from the site over a period of 3-4 months to licensed facilities within the Kildare region. Whilst no haul routes have been submitted with the proposal, it is noted that such routes are required to be agreed with the Transportation Section prior to the commencement of works.

Machinery Yard

It is submitted in the documentation that the new Machinery Yard will include a workshop and office buildings and will serve as a hub for the services and operations currently undertaken by the Council including coordination of winter maintenance, surface dressing operations, road repairs, street sweeping, bitumen storage, fuel storage (bunded), vehicle/plant repair and maintenance and management.

Access to the development is via a security gate/barrier close to the site entrance, with a second secure access point into to the yard and barn, located further south.

Provision is made in the proposal for internal, external and covered storage for materials associated with the machinery yard. Truck washing facilities are also proposed and provided for on site, with segregated water run off, to allow for recycling of water.

The administrative and workshop building is located towards the front (north) of the site, with the salt barn located at the rear, south of the site.

Regional salt barn


The proposed Regional salt barn will provide for the storage of 23,000 tonnes of salt for use by the Council and other local authorities in the region as part of their winter maintenance operations. The storage and distribution of salt will be operated by Kildare County Council on behalf of the Department of Transport, Tourism and Sport. The salt barn structure has 3,480 sq m floor area, with an open fronted lean to structure proposed for the side of the barn to be used for the storage of snow ploughs, gritters and other equipment and also includes a 58 sq m welfare unit for use by night time gritter drivers.

The structure is typical industrial style portal frame development, with "double A" roof profile, and fibre cement cladding over concrete walls. The barn has a ridge height of 13.5m and a finished floor level 0.5m higher than the finished floor level of the administrative building. The length of the structure is c. 70m, with a width of 58.6m.

Vehicular access to the structure is proposed at 4 no. locations, 2 no. on northern elevation and 2 no. on the south western elevation. An additional vehicular access is available on the north eastern elevation, providing access to a rock salt storage area, to be used for production of brine. It is indicated in the documentation, that heavy goods vehicles will be used to access the salt barn and access routes will be delineated on site.

It is envisaged that salt will be delivered using HGVs. The salt barn can hold up to 23,000 tonnes of salt, which will be delivered at a maximum rate of 2,000 tonnes per day. This will involve a maximum of 70 HGVs per day to fill the barn in approximately 12 days. This can be managed by Kildare County Council to reduce the number of HGVs per day if required. The delivery of 23,000 tonnes of salt in one period will only occur once. It is also envisaged that once the barn is initially filled to capacity, it will not be allowed to go below 50% capacity. Therefore after the initial fill, all subsequent replenishment will involve a maximum of 11,500 tonnes. At a delivery rate of 70 HGVs per day, it will take 6 days to replenish the barn.

The barn has been designed to consist of two compartments to facilitate its controlled replenishment. Gritters will be loaded using a teleporter. The gritters will be filled both inside and outside the barn - when the barn is full gritters will be loaded on the concrete apron in front of the doors. As the salt is used and space becomes available within the barn, the gritters will be loaded inside the structure.

Brine manufacture/ storage

Brine storage is proposed on site. The submitted documentation does not indicate in detail the intended manufacturing details. However, it is understood that the brine production facility is a simple process that consists of two water storage tanks. Tank 1 approx. 10,000 litres – 2.26m diameter x 3.2m high and Tank 2 - approx. 25,000 litres – 2.75m diameter x 5m high. Tank 1 stores potable water. The potable water from tank 1 is mixed with salt in tank 2 to produce brine. The brine solution from tank 2 is used in road treatment during winter. The salt used in the brine production is stored in a

dedicated cubicle within the saltbarn (as per drawings) and is added to tank 2 as required.

Other siting and design matters

The scale and bulk of the buildings and structures on site are typical of industrial type buildings. The administrative building is a mix of office and industrial uses and the design, configuration and layout reflects same. It is considered that the scale and bulk of the development is acceptable. The site will be visible from the immediate locality, but not to an extent to cause significant detriment to surrounding land uses or amenity.

Boundary treatment at the site comprises the retention of the trees and hedges, supplemented by additional hedgerow planting and fencing. It is considered that the retention of the hedgerows is acceptable and in accordance with the recommendations set out in the Ecological Impact Assessment submitted with the proposal.

Staff and visitor parking provision is located along the site frontage, with additional vehicular parking located elsewhere on the site.

Technical Matters

A number of technical reports on the proposal have been received in relation to the proposed development. The details are indicated below:

Roads, Transportation and Public Safety

No objection, subject to recommendations to be agreed prior to commencement of the development, including, but not limited to:

- provision of a Construction Management Plan including the access to the site, proposed haul routes;
- provision of details in relation to turning movements on site including auto-track analysis;
- details of public lighting for the development.

Water Services/Irish Water

No objection subject to recommendations including:

- water and sewerage connection agreements with Irish Water;
- water services infrastructure to be in accordance with Irish Water Standard Details;
- surface water drainage to comply with Greater Dublin Strategic Drainage Study to incorporare Sustainable Urban Drainage Systems (SUDS);
- Rainfall runoff from the development to be segregated with salt storage area segregated from the remainder of the development.

Environment

No objection. Final details regarding the requirements of the Environment Department, shall be agreed by the Planning Authority prior to commencement of the development.

Appropriate Assessment (The Natura 2000 Network i.e. Special Areas of Conservation)

A Stage 1 Appropriate Assessment Screening has been prepared for Kilgallen and Partners Consulting Engineers and is submitted with the documentation. The report notes that the closest Natura 2000 site to the development is Mouds Bog SAC c.5.7km west of the site. The report concludes that no significant effects on Natura 2000 sites are likely and therefore a Natura Impact Statement (Stage 2) is not required.

A Kildare County Council determination and Chief Executive's Order has been prepared and concludes that a Stage 2 Appropriate Assessment is not necessary to inform the proposed development.

EIAR Screening

An Environmental Impact Assessment Screening report has been prepared by Kilgallen and Partners Consulting Engineers. The Screening Conclusion, formed on completion of the Environmental Impact Assessment Screening, states that, having regard to the nature, scale and location of the proposed development, by itself (sub threshold) and in combination with other plans and projects, an EIA is not required. A Kildare County Council determination and Chief Executive's Order has been prepared and concludes that the environmental effects arising from the proposed project will generally be localised minor in nature and occur principally during the construction phase and that EIA is not required.

It is considered that the proposal is:

- in accordance with the provisions of the Kildare County Development Plan 2017–2023;
- and would therefore be in accordance with the proper planning and sustainable development of the area.

Recommendation

It is recommended to the Mayor and Members of the Kildare County Council that the proposed development be proceeded with, subject to the modifications set out below.

Modifications:

- 1. The proposed development shall be carried out in accordance with the plans and particulars placed on public display on 26/02/2019, except where altered or amended by the following modifications.
- 2. Final details regarding construction management, haul routes, public lighting, foul and surface water and water supply requirements raised by the Transportation and Water Services Departments in their reports and responded to by the Transportation Department in its report on submissions, (included as Appendix 1 of this Report), shall be agreed with the Planning Authority prior to commencement of development.
- 3. Final details regarding the requirements of the Council's Environment Department raised in its report and responded to by the Transportation Department in its report on submissions, (included as Appendix 1 of this Report), shall be agreed with the Planning Authority prior to commencement of development.
- 4. All necessary measures shall be taken, to ensure comprehensive protection of local aquatic ecological integrity. This shall be addressed by the incorporation, into the contract documents for the construction and management of the proposed development, of the relevant issues/comments/recommendations raised by Inland Fisheries Ireland.
- 5. All metal boundary railings shall be powder coated.
- 6. All boundary walls visible from public view shall be rendered or faced with selected brick.
- 7. In the interests of residential amenity the hours of construction activities on the site shall be restricted from Monday to Friday 08.00 18.00, Saturday 08.00 13.00 or as agreed with the Planning Department. No building activity shall be undertaken on Sundays and Bank Holidays under any circumstances.

8. Prior to the commencement of development, the Council shall engage with An Garda Siochána with a view to agreeing the use of the weighbridges on site for Garda purposes if required, during the course of its duties.



The proposed development, which is the subject of this Part 8, will include the following:

- o A 4 bay mechanical workshop including shot blasting, spray painting and welding facilities.
- A Regional Salt Barn and Welfare facilities for drivers

- Weighbridges
- o Car Park, truck and van parking
- o Rainwater Harvesting Facilities

Having regard to Article 6(3) of the Habitats Directive and Part XAB of the Planning and Development Act 2000 (as amended), the guidance contained in the document entitled "Appropriate Assessment of Plans and Projects in Ireland Guidance for Planning Authorities" (published by the Department of Environment, Heritage and Local Government in 2009) and following an examination of the objective information provided in the "Appropriate Assessment Screening Report" (the Screening Report) prepared by SLR Environmental Consulting (Ireland) Limited on behalf of Kilgallen & Partners Consulting Engineers, Kildare County Council, as the Competent Authority, determines that the proposed development of a new Machinery Yard and a Regional Salt Barn at Jigginstown, Newhall, Naas, Co. Kildare, individually or in combination with other plans and projects, does not have the potential to give rise to likely significant effects on European Sites, their conservation objectives or integrity, and therefore does not require an Appropriate Assessment.

The principal reasons supporting this determination include:

- A determination that there is no potential direct habitat loss within Moulds Bog SAC as a result of the proposed development as Moulds Bog is c.5.7km west of the subject site.
- There are no pathways between the subject site and Moulds Bog SAC which could result in indirect effects to the Natura 2000 site arising from emissions to air or water during the construction and operation of the proposed development.
- The distance between the subject site and any other designated European Sites, and the lack of
 any significant direct hydrological linkages between the subject site and any designated European
 Sites, ensures that no significant cumulative impact would be envisaged for the project alone or
 in combination with other projects.

Therefore a Stage 2: Appropriate Assessment will not be required to inform the project appraisal either alone or in combination with other plans or projects, with respect to any Natura 2000 sites and their Conservation Objectives.

Having regard to EIA Directive 2011/92/EU as amended by Directive 2014/52/EU (the EIA Directive), the guidance contained in: "Environmental Impact Assessment (EIA) Guidance for Consent Authorities regarding Sub-Threshold Development" (published by the Department of Environment, Heritage and Local Government in 2003); "Environmental Impact - Assessment of Projects - Guidance on Screening" (published by the European Commission in 2017); "Guidelines for Planning Authorities and An Bord Pleanála on carrying out Environmental Impact Assessment" (published by the Department of Housing, Planning and Local Government in 2018); and on the basis of the objective information provided in the "EIA Screening Report" (the Screening Report) prepared by Kilgallen & Partners Consulting Engineers, Kildare County Council, as the Competent Authority, determines that the proposed development of a new Machinery Yard and a Regional Salt Barn at Jigginstown, Newhall, Naas, Co. Kildare, individually, and in combination with other plans and projects, does not require and Environmental Impact Assessment.

It is considered that the Screening Report has been carried out giving full consideration to the EIA Directive and in particular to Annex I, II and III of that Directive, which set out requirements for mandatory and sub-threshold EIA.

As the proposed development is sub-threshold, it has, therefore, been assessed on a case-by-case basis in accordance with the criteria for determining whether or not a development would or would not be likely to have significant effects on the environment as outlined within Annex III of the EIA Directive.

It is further considered that the Screening Report contains a fair and reasonable assessment of the likelihood of significant effects of the proposed project on the environment, having regard to the foregoing and in particular:

- The size and design of the subject proposal;
- The limited ecological impact of the proposed development;
- The lack of any archaeological, heritage or cultural impacts;
- The use of natural resources, in particular land, soil, water and biodiversity;
- Potential for pollution and/or nuisance;
