1. Rathangan (Outside the Bridge Bar) Bus Stop No: 105741	The available space for the installation of a bus shelter in this location is very restricted. Considerable civil improvement works would be required including the loss of public car parking spaces due to the restricted site. The installation of a shelter at this bus stop location would result in third party obstruction and inconveniences.
6. Kilmeague (Outside the Church) Bus Stop No: 152401	The available space and site for the installation of a bus shelter in this location is very restricted. Considerable engineering works would be required to facilitate the installation of a bus shelter at this location as there is an old retaining wall of approximately 2.5 meters in height behind the bus stop, securing the grounds upon which the adjacent church is positioned. In addition the church and its curtilage at this bus stop location is a protected structure.
7. Kilmeague (Opposite the church) Bus Stop No: 102671	The available space for the installation of a bus shelter in this location is restricted and there is a level fall of approximately 400 to 500 mm across a 5 meter distance at the bus stop. The 'footpath' is surfaced in an historic and distinctive cobble finish. In addition the installation of a shelter at this bus stop location would result in third party obstruction and inconveniences for the residents in the immediate vicinity of the bus stop.
8. Brownstown (Outside Rising Sun pub) Bus Stop No: 132491	The available space for the installation of a bus shelter in this location is restricted. Considerable civil improvement works would be required which would include the loss of public car parking spaces due to the restricted site. The installation of a shelter at this bus stop location would result in third party obstruction and inconveniences for the residents in the immediate vicinity of the bus stop.
9. The Curragh Camp (Opposite Post Office)	The available space for the installation of a bus shelter in this location is very restricted and there is a level fall of approximately 500 to 600

<p>24. Sallins (Mainstreet at the entrance to train station) Bus Stop No: 135601</p>	<p>The available footpath space for the installation of a bus shelter in this location is restricted. Installation of a shelter in this location would generate serious safety concerns in relation to visibility and sightlines as the bus stop is located very close to an entrance / exit from the train station. In addition a shelter in this location would create potential third party inconveniences and obstruction for nearby residents.</p>
<p>25. McNamee's, Dublin Road Celbridge Bus Stop No: 7108</p>	<p>The available footpath space for the installation of a bus shelter in this location is very restricted. The footpath is too narrow. In addition the bus stop in this location serves Dublin Bus services 67 / 67X. It would be premature to install a shelter in this location pending the outcome of the Bus Connects review of the Dublin Bus network.</p>
<p>26. Obelisk Lane on Celbridge / Maynooth Road</p>	<p>The bus stop is sited in the vicinity of a dangerous 4 way junction i.e. sightlines etc. Possible consideration might be given to the relocation of the bus stop to provide a safer solution. In addition the bus stop in</p>
